We, the undersigned qualified electors residing within the following described territory within the City of Chicago, County of Cook, State of Illinois: Beginning at the intersection of Addison Street and North Central Park Avenue continuing north along the East side of North Central Park Avenue to the North side of West Waveland Avenue; continuing West along the North side of Waveland Avenue to the east side of North Monticello Avenue; continuing north along the East side of North Monticello Avenue to the South side of West Byron Street; continuing west along the South side of West Byron Street to the East side of North Lawndale Avenue; continuing North along the East side of North Lawndale Avenue to the South side of West Irving Park Road; continuing East along the South Side of West Irving Park Road to the East side of North Elston Avenue; continuing North on the East side of North Elston Avenue to the South side of West Belle Plaine Avenue; continuing East along the South side of W.
