Dear Chairman Bynoe:

On January 29, 1998 I introduced Aldermanic Application A1887 into the City Council and the purpose of that amendment was to make a technical amendment to Planned Development #578. The purpose of that amendment was to eliminate the sale of buildings and home improvements supplies and other retail uses as permitted within Subarea A of that Planned Development. This matter was heard by your Commission on August 12, 1999 and the proposed amendment to Manufacturing Planned Development #578 was recommended for approval by your Commission. This amendment was never called up for hearing before the Committee on Zoning.

The purpose of this letter is to inform you that I have sent a letter to the Chairman of the City Council on Zoning informing him that I am withdrawing this amendment from further consideration by his Committee and as a courtesy I wanted you to be aware of this withdrawal. Circumstances have changed in my community and I now wish to permit the sale of buildings, home improvement supplies and other retail uses as permitted uses within Subarea A of this Planned Development.


